

## **Spinderella Studios: RENT-A-POLE AGREEMENT & LIABILITY**

1. Please remove lotions and oils before using the stand-alone pole and stage.
2. Metal objects such as jewelry and buckles must be removed prior to using the stand-alone pole and stage to avoid damaging/scratching.
3. Anyone under the influence of drugs or alcohol must not use the stand-alone pole and stage.
4. At any time, the combined weight on the stand-alone pole and stage must not exceed 250 lbs as this is the maximum weight the unit can handle.
5. Anyone with head, back, neck or any muscular-skeletal injuries or disabilities, pregnant women, children under 3 years of age, and others who may be susceptible to injury from falls and bumps are not permitted to use the stand-alone pole and stage at any time.
6. The stand-alone pole and stage shall not be disassembled or moved from the addressed location noted by you, the Lessee.
7. The location which the pole will be set up will need to be discussed at least **fourteen days in advance** and confirmed with Spinderella Studios before its delivery. Currently, Spinderella Studios can only deliver/set-up the stand-alone pole and stage within the greater Seattle and Eastside areas of King County, Washington.
8. Your safety as well as the safety of any other persons who uses the stand-alone pole depends on you. As the Lessee, the safety of all who come in contact with the stand-alone pole and stage or parts thereof is YOUR responsibility.
9. You are responsible for the cleaning of the stand-alone pole and stage using a towel and water or rubbing alcohol before it is scheduled to be picked up.
10. The stand-alone pole should be in good working order upon pick-up. Theft or any damages done to the unit will be at the expense of the Lessee. Along with the rental fee, a \$100 security deposit is required which will be set aside in case any notable theft/damages to the stand-alone pole and stage occur during the time it is leased. If there is no theft/damage to the stand-alone pole and stage upon pick-up, this deposit will be returned to you, the Lessee.

### **Cancellation Policy**

A 24 hour notification of cancellation is required for a complete refund.

**Release of Liability**

The Lessee shall be in charge of the stand-alone pole and its operation and is fully responsible for the unit for as long as it is leased for. The Lessee shall pay for any theft and/or damages done to the stand-alone pole while on the addressed premises. Marisa Oka and associates of Spinderella Studios is/are not responsible for any injury occurring to any person or persons in contact with the stand-alone pole.
